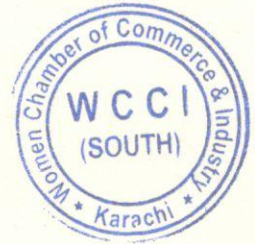

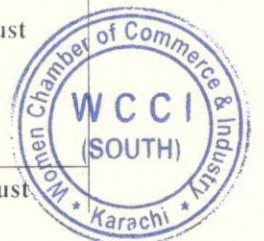

The Secretary General shall display provisional voters list within seven days of the announcement of Election Schedule of all members eligible to vote along with their national tax number, sales-tax-registration number , if applicable, the name and national identity card number of their representative	15 th July
4.	Ashora Moharm Holidays	16 th & 17 th july
5.	The members who have any objection on the provisional voters list filed objection in writing to the Secretary General within seven days of the issuance of the voters' list.	22 nd July
6.	The Secretary General shall decide the objections within five days from receipt of objections.	29 th July
7.	Any member aggrieved the decision of Secretary General may file appeal before the Election Commission within three days.	3 rd August
8.	Decision of Election Commission	6 th August

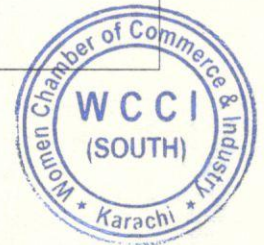

9.	Appeal before the Regulator TO against the decision of the Election Commission within Three days of decision of Election Commission.	07 th August
10.	Decision of Regulator Trade Organizations (shall be deemed to be final)	10 th August
11.	Display of Final voter list	12 th August
12.	Within four days of the display of the final list of voters' any person who is eligible to contest the elections for the vacant post, shall send his nomination to the Secretary General duly proposed and seconded by a duly registered voter and signed by the candidate.	15 th August
13.	Within twenty four hours of receipt of nomination papers, a copy of the final list of voters' shall be provided to each contesting.	19 th August
14.	The nomination papers shall be scrutinized and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	20 th August
15.	The objections, if any, to the nomination of the candidates can be filed to the Election Commission within twenty four hours of issuance of the list of candidates, which shall be decided by the Election Commission within two days.	22 nd August

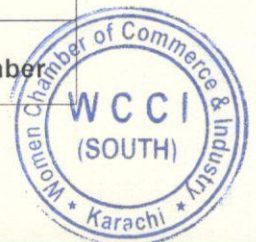

17.	Any candidate aggrieved by the decision of the Election Commission may file appeal to the Regulator within two days, which shall be decided by the Regulator within seven days.	30 th August
18.	Decision of Regulator which shall deemed to be final	02 nd September
19.	Withdrawal of Nominations.	04 th September
20.	Within two days of the decision of the Regulator the Election Commission shall issue the final list of candidates.	05 th September
21.	Within five days of display of final list of candidates, the election of Members of Executive Committee will be held.	09 th September
22.	Within two days of the election, any person elected as Members of Executive Committee shall send his nomination for election as an Office Bearers (President, Senior Vice President, and Vice President) duly proposed and seconded by an elected Executive Committee member and signed by the candidate to the Election Commission.	13 th September
23.	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	18 th September
24.	Poling for election of Office Bearers (President, Senior Vice President, and Vice President) shall be held.	20 th September
25.	Annual General Meeting for announcement of Election result	28 th September
