



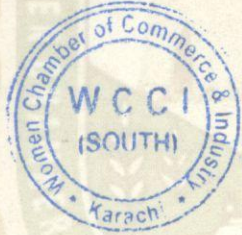

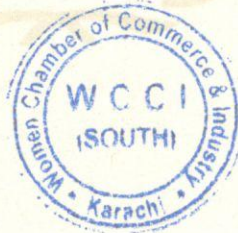

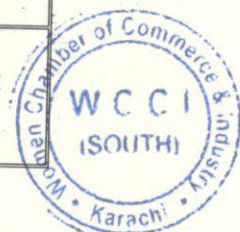

4.	Secretary General shall display within seven days of the announcement of Election Schedule the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number , if applicable, the name and national identity card number of their representative	25 th July
5.	The members who have any objection to the entries in the list of voters' shall send their objections in writing to the Secretary General within seven days of the issuance of the voters' list.	01 ST August
6.	Intimation of action on the objections by the Secretary General within five days from receipt of objections.	07 th August

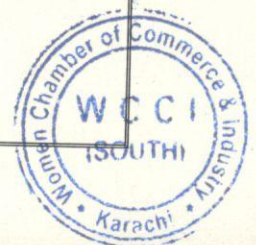

9.	Appeal against the decision of the Election Commission or in case the Election Commission fails to decide within the stipulated time provided under preceding clause any person aggrieved by its decision may appeal to the Regulator of Trade Organizations within ten days.	21 th August
10.	Decision of Regulator of Trade Organizations (shall be deemed to be final)	24 th August
11.	Within two days of the decision of the Regulator the final voters' list shall be issued.	25 th August
12.	Within four days of the display of the final list of voters' any person who is eligible to contest the elections for the vacant post, shall send his nomination to the Secretary General duly proposed and seconded by a duly registered voter and signed by the candidate.	29 TH August

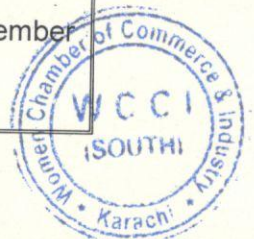

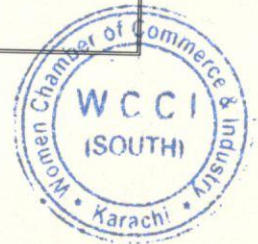
13.	Within twenty four hours of receipt of nomination papers, a copy of the final list of voters' shall be provided to each contesting.	31 st August
14.	The nomination papers shall be scrutinized and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	01 st September
15.	The objections, if any, to the nomination of the candidates can be filed to the Election Commission within twenty four hours of issuance of the list of candidates	02 nd September
16.	Decision of Election Commission	04 th September
17.	Any candidate aggrieved by the decision of the Election Commission may file appeal to the Regulator within two days,	07 th September
18.	Decision of Regulator of Trade Organizations which shall deemed to be final	12 th September

19.	Withdrawal of Nominations.	14 th September
20.	Within two days of the decision of the Regulator the Election Commission shall issue the final list of candidates.	16 th September

Within two days of the election, any person elected as Members of Executive Committee shall send his nomination for election as an Office Bearers (President, Senior Vice President, and Vice President) duly proposed and seconded by an elected Executive Committee member and signed by the candidate to the Election Commission.	21 st September
23.	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	22 nd September
24.	Within two days of display of final list of candidates, the polling for election of Office Bearers (President, Senior Vice President, and Vice President) shall be held.	24 th September
25.	The final result shall be officially announced at the Annual General Meeting of the Association.	30 th September
